# **CAGR Square's Commitment to Privacy**

CAGR Square recognizes and respects your privacy. This Privacy Notice describes the types of personal information we obtain, how we use that information and to whom we disclose it. Non-public personal information means personally identifiable financial information that is not publicly available and any list, description or other grouping of consumers (and publicly available information pertaining to such consumers) that is derived using any personally identifiable financial information that is not publicly available.

CAGR Square does not sell your non-public personal information to any third parties. CAGR Square uses your nonpublic personal information primarily to complete financial transactions that you request or to make you aware of other financial products and services offered by CAGR Square or its affiliates.

# **Information CAGR Square Collects About You**

CAGR Square collects the following categories of non-public personal information about you:

- Information that you provide, which may include your name and address, social security number or tax identification number, date of birth and/or other information.

- Information about transactions and balances in accounts with non-affiliated third parties; and
- Information from consumer reporting agencies.

### **How CAGR Square Discloses Your Personal Information**

Below are the details of circumstances in which CAGR Square may disclose non-public personal information to third parties:

- In order to complete certain transactions or account changes at your direction, it may be necessary to provide certain non-public personal information about you, such as your name, social security number or tax identification number or date of birth, to companies, individuals or groups that are not affiliated with CAGR Square, such as administrators, custodians, transfer agents, accountants, attorneys and broker-dealers.
- In order to notify you about other financial products and services that a CAGR Square affiliated company offers, CAGR Square may share non-public personal information it has about you, such as your name, contact information or information about transactions and balances in accounts with CAGR Square or its affiliates, with a CAGR Square affiliated company.
- In certain instances, CAGR Square may contract with non-affiliated companies to perform services for or on behalf of CAGR Square.
